Together, we can support rescue and rehabilitation raptors which will contribute to healthy bird populations, demonstrate land stewardship and amplify our mission and create something truly extraordinary.</p> <p>The center will empower the Rocky Mountain Raptor Program to continue our vital work of rescuing, rehabilitating, and releasing 75% of the over 300 majestic raptors that arrive at our facility each year. This location also complements the migratory bird banding station operated by Bird Conservancy of the Rockies at Pine Ridge Natural area providing an opportunity for the community to connect with nearly 100 species of birds. We envision a state-of-the-art rehabilitation center for continued collaboration with the CSU Veterinary Teaching Hospital, strengthening and expanding our existing partnership. Moreover, our vision encompasses a welcoming center that invites community members and students of all ages to engage in experiential learning. Through interpretive trails and habitat restoration projects, we will educate visitors about the rich ecosystems of the Rockies while contributing to the larger mission of revitalizing the surrounding landscape of the damaged Hughes property. Together we can join forces to inspire and nurture a deeper connection with nature for everyone.</p>

<p>This proposed use would be a truly unique gem in our community, significantly enhancing learning and connections to our natural landscapes and increasing Fort Collins's appeal. It aligns perfectly with the vision outlined in the ballot language, focusing on wildlife rescue and land restoration, recreation, open space, and natural areas. Several compelling themes have emerged throughout our community engagement process, underscoring this initiative's importance. Education is one of the valuable themes—this concept will provide rich educational opportunities for all residents. We envision offering engaging wildlife-related programming, interpretive trails, and conservation initiatives. The design would be sensitive to the surroundings, minimize light pollution, and exemplify stewardship through sustainable and environmental building practices. Over time, the goal would be that added plantings will further reduce visibility and enhance the overall aesthetic. <p>The Rocky Mountain Raptor Program has proudly shared its vision with the community even before our leadership discussed the potential Hughes site in 2022. Our services have been greatly appreciated in our community for many years and we have received an outpouring of positive feedback and heartfelt gratitude for the enriching learning opportunities this initiative promises to offer. Many have participated in this Civic Assembly process. The City of Fort Collins made a landmark investment by purchasing the land for \$12.5 million. If this land use is allocated for a single purpose, it could impose a considerable financial burden on the city department responsible for its upkeep, making it challenging to dedicate funds for essential restoration or to acquire additional conservation areas. The organizations advocating for wildlife rehabilitation, nature, and education facilities are committed to raising funds independently. Our goal is to secure a long-term lease on the land and explore the possibility of utilizing city tax revenue for vital infrastructure improvements, such as water, sewer, electricity, sidewalks, and curb and gutter enhancements. The center will serve as a welcoming space creating a sense of place for people of all ages to visit, connect with, explore and learn about nature and stewardship.

The center will increase access to nature for all people including those with seen and unseen disabilities, people wanting to connect with nature including those who are not sure how to get started and those wanting to roll up their sleeves, learn and help with land restoration. In addition, wildlife rehabilitation will improve the lives of animals and create inspirational opportunities for people of all ages. It will bring to life classroom learning about our local wildlife, landscapes and people, while complementing existing river and eco week programs and expanding hands-on learning opportunities for elementary and high school students. The former Hughes stadium needs resources and people to improve the health and condition of the land. The City doesn't have the resources alone to restore and improve this site without affecting their budget for existing and new natural areas. A center like this is lacking on the central west side of town and improvements on site will foster healthier adjacent natural areas.
